Application to join the Greater Chapel Hill Association of REALTORS® (GCHAR) as an Associate member must be made by completing this form. According to GCHAR Bylaws, Associate membership may be granted to individuals who are not actively engaged in the business of selling real estate. Membership is based on individuals, not companies or firms. Associate members receive the same benefits and services as REALTOR® members with the exception of voting rights. Associate members may not serve on the Board of Directors of GCHAR.

Associate membership is provisional based on Board of Director approval of application. The cost of Associate membership is \$295 a year plus a one-time administrative fee of \$99. Application fees are nonrefundable unless the Board of Directors elects not to approve your membership into GCHAR.
